The measures to improve farm tenancies apply to England only, and include modified succession rules and new guidance for rent reviews. The Bill also includes provisions for tenants to object if landlords refuse to give consent for changes to the farm which are deemed necessary to meet financial assistance criteria or meet new regulations. Big Farm Bird Count 7 – 16 February 2020

Time to start planning the Big Farmland Bird Count (BFBC) back for the 7th year.

This nationwide citizen science project takes just 30 minutes spotting birds on your land and is a great opportunity of showing what your conservation efforts deliver on the ground. GWCT who run the count hope that it will act as a catalyst for you to start building your own long-standing wildlife records.

How to take part in three simple steps

- 1) Download your count sheet from the BFBC website www.bfbc.org.uk
- 2) Count your birds! On a day between 7th and 16th February, spend about 30 minutes recording the species and number of birds seen on one particular area of the farm.
- 3) Once you've completed your count, simply submit your results at www.bfbc.org.uk

It's a great chance for local birders and farmers to team up and do the survey together.

The Wye & Usk Foundation – Here to Help **Update on the projects running in Herefordshire!**



➤ **Natural Flood Management:** There is still grant available during 2020 in target catchments to support delivery of actions that will increase water holding capacity. So far >£30k has been offered for grassland aeration, subsoiling, cover cropping, attenuation ponds, hedge planting and leaky dams! To find out more about the target catchments visit:

➤ **Pesticides:** Application window for the Severn Trent **STEPS Grant Scheme** has been extended to the end of Feb. It is restricted to the **Drinking Water Safe Guarding Zone** which follows the main rivers so if you farm on the main stem of the Wye, Lugg or Frome and would like to improve a pesticide handling area or biobed/biofilter please contact Mike or Abi on the details below. STEPS is a competitive scheme and can also support biodiversity options like buffer strips, winter bird food and pollen mixes.

➤ **Water Quality:** The levels of phosphate in the rivers and streams is still higher than it should be and we are working hard to support local farmers to reduce losses from agricultural sources – which still contributes 50% of the P in our rivers. We are able to provide free confidential farm advice for any yard or land management challenges you may be facing. We can provide soil structure assessments, OM testing, yard advice, stewardship advice etc across the entire county – if you'd like help with anything please contact one of our advisers:

Free Advice and Farm Visits

Water Quality We continue to offer farm visits and advice on a wide range of areas that will improve water quality and water management in addition to support for Countryside Stewardship Water Quality Capital items on priority holdings.

Air Quality Would you like to understand what air quality and ammonia means for your farm? Following the launch of Defra's Clean Air Strategy in 2019 CSF are offering advice and events on improving air quality and reducing ammonia emissions, in addition to their current advice on water quality. If you are a dairy, beef or free range poultry unit (less than 40,000 birds) and would be interested in hearing more, please contact your local Catchment Sensitive Farming Officer (CSFO) or book into the event on 4th Feb.

Specialist Advice Visits

Catchment Sensitive Farmers Officers (CSFO) are now able to offer around thirty different specialist advice visits for priority farms within the Wye catchment. Several of these are new to the project, having been designed to meet industry demands.

These include:

Assessment and Monitoring of Soil Health An in-depth assessment of soil health through a combination of approaches, including detailed soil nutrient analysis, profile and field examination. Recommendations will be provided to help improve soil condition, increase plant growth and reduce erosion, weed, pest and disease problems, while improving air and water quality.

Water Resources Audit Would you like to improve your farm's resilience to drought, regulatory changes and identify options for the most effective water storage and efficiencies? This new visit will advise on water resource risks and make detailed, farm-specific recommendations on options to ensure water resilience and efficiency.

Woodland for Water and Air This visit will investigate whether woodland creation or management on your farm could provide additional benefits for water and air quality, as well as business opportunities (e.g. wood fuels, stock shelter). Bespoke advice will also be given on location and design of woodland or tree planting, and available grants

Prince's Trust "Get Into Woodlands" Course 2020

The Get Into Woodlands course, delivered in partnership with Duchy of Cornwall and Herefordshire & Ludlow College, is a fantastic opportunity for young people to gain the skills and experience that they need to get ahead in the forestry sector.

The course is open to young people aged between 16-30 from across England and Wales, with travel expenses paid and local accommodation provided to those from far afield. Participation on the course will not affect any benefits.

There is a taster day on the 26th February at the Holme Lacy Campus of Herefordshire & Ludlow College, and then the course runs from the 2nd-27th March 2020.

It includes three weeks forestry training and one week of work experience within the industry.

Participants will gain qualifications in Chainsaw maintenance & Cross Cutting (CS30), Manual Handling and Emergency First Aid at Work +F.

The Prince's Trust also offer help with CV building and employability skills, as well as up to 6 months mentoring support.

The Prince's Countryside Fund – still open for applications

The Herefordshire Federation of Young Farmers' Clubs (HFYFC) working in partnership with Herefordshire Rural Hub have secured funding to provide support for training in a **rurally based career**. The funding is easy to access. All you need to do is select which course you would like to go on and complete the application form. If your application is approved you will be able to reclaim **70%** of your training and test costs, up to a maximum of **£250**. **Applicants must be a current member of HFYFC or a past HFYFC member (up to 40 yrs old).**

The fund will support training that will; **improve your employability, increase or improve your skill set, improve your safety or allow you to undertake extra responsibility in your current job.**

Some examples of training that has been funded so far:- **B+E Trailer, Chainsaw Certification, Pesticide Applications, Shearing, Artificial Insemination, Tractor Driving, Forklift Truck Driving, Rodent Control** and many more

Whatever training you are applying for, **please ensure that you submit your application in good time before your course is due to take place, as training cannot be funded retrospectively.**

The Jack Hughes Fund - administered by Herefordshire Community Foundation

From September 1st 2019 the Jack Hughes Fund has been extended to staff aged over 40 years working on a Herefordshire farm. The amount of funding available still remains up to a maximum of £70% of the course cost but has been increased to an overall maximum of £200.

The programme is available for farmers and farm staff aged over 40 (limited to one family member/employee per farming business per year).

It will specifically provide funds to support those who require:

- retraining or upskilling as they are leaving the industry
- training to support a new farm diversification enterprise
- training or business support for succession planning

Funding will also be available for farm related training courses (examples below)

- Safe use of pesticides – PA1, PA2, PA6
- Rodent control on farms
- Emergency first aid
- Food safety (Basic Food Hygiene)
- Chainsaw Maintenance & Cross Cutting (CS30)

Other courses will be considered on application

The funding is easy to access, but please note that the project will not support training retrospectively & places will be limited. Applicants need to be resident in Herefordshire.
